REPORT OF THE STUDENTS AND STAFF GRIEVANCE REDRESSAL COMMITTEE 2019-20

For the Academic Year 2019-20, the Students and Staff Grievance Redressal Committee constituted of the following members:

There was only one matter reported to the Grievance committee during the entirety of Academic Year 2019-20, which is as follows:

A complaint was filed and forwarded through the Principal to the Grievance Committee on 18/06/2019 by Ms. Rupali Prajapati Ramesh and Ms. Sarita Rajesh Yadav, Ph.D research students against their Guide for non cooperation with them with respect to their research work.

The committee immediately convened and decided to call on the aggrieved party for a hearing on 22/06/2019 and their grievance was heard in detail.

The grievance of the students was that their guide was not giving them sufficient time or guidance as to how they should write their chapters. On the contrary, every time they approached the guide, she pointed out their errors but did not show as to how they should be corrected maintaining a haughty and rude demeanor all the time.

The students demanded that in the face of constant mental strain, due to the above mentioned circumstances, they no longer wished to continue their research work under the said Guide and therefore they be issued a No Objection Certificate from the guide so that they may be free to pursue their Ph.D under the guide ship of some other person.

The Committee decided to ask for a written explanation to the above allegations from the guide and accordingly issued a letter for the same on 24/06/2019.



The reply from the guide was obtained on 27/06/2019 which clearly pointed out severe lapses on the part of the students in terms of lack of basic knowledge and irregularity in attendance and timely submission of their research work. Evidence to this regard was also provided by the guide.

After hearing both sides of the matter and deliberating over all aspects of the case, the committee members unanimously decided that both sides did have serious and genuine grievances against each other therefore, without blaming any one side, the only conclusion that seemed appropriate in this regard was that it was very likely that nothing fruitful was to be achieved under such association and as such, it was in the best interest of both parties that the NOC be granted to the students.

Accordingly on 08/07/2019, the Confidential Committee Report was submitted to the Principal's office.
